Sub: Provisional Admission to Postgraduate programme in Basic Sciences after counselling for the 2nd semester of the academic session 2025-26.

(Agri.) The candidates thereafter shall report to the concerned Dean of the Faculty (along with a complete set of all the documents & 03 Nos. of Passport size photographs) for registration in the 1st year /2nd semester of the academic session 2025-26.

The candidates who fail to report for admission in the University on the aforesaid dates his/her admission shall be treated as cancelled.


