Terms and conditions

1. Any offer without CDR shall not be entertained.
2. The rates should be quoted on per quintal basis
3. Conditional bids shall be rejected out rightly.
4. The quantities mentioned above are approximate and can vary.
5. **The weight of gunny bags shall be included in weight of the wheat rejections.**
6. Envelope containing the bid amount be labeled as "Left-over Processed Grains/Seed, Rabi 2025-26".
7. 100% amount of the accepted bids shall have to be deposited within five days of acceptance of the bid.
8. The successful bidders shall have to lift the grain within five days after depositing the full amount and issuance of authorization.
9. The University shall not be responsible for any kind of damage whatsoever thereafter.
10. The auction committee reserves the right to accept or reject any tender without assigning any reason thereof.
11. The bidder desirous of representing themselves on the opening of the bid can do so in person or through their authorized representative.
