This is for the information of all desirous candidates seeking admission to various Undergraduate and Postgraduate Degree Programmes of the University that the result of SKUAST-J CET (UG & PG) 2026 has been declared and uploaded on the University website.

The re-counselling sessions for admission shall be conducted as per the schedule given below. All eligible candidates are advised to attend the counselling strictly according to their merit position and the notified schedule. Candidates are required to bring the duly filled **Counselling Option Form** and **Checklist of Documents**, which shall be downloaded from the University website www.skuastjammu.ac.in, along with all the prescribed original documents and self-attested photocopies, as applicable.

Reporting time for counselling shall be 9:30 a.m and time of counselling be 10:00 a.m Sharp

The Terms and Conditions:

The candidates of the rank and score mentioned above, before attending the counselling must ensure that the following conditions are strictly adhered, failing which the Admission cum Counselling Committee shall be within its rights not to consider any request, in case of deviation of these conditions:

1. The candidates attending counselling shall have to produce the original documents viz. Matric (D.O.B), Marks Card of 10+2, Domicile Certificate, Migration Certificate, Character Certificate, Category Certificate, (if belonging to any reserved category), in original along with self-attested photo copies of all the above documents, admit card of SKUAST-J CET-2026.
2. The candidates before attending the counselling on the aforesaid date shall have to deposit counselling fee Rs. 1000/- (Non-refundable) through online mode preferably one day before or on counselling date up to 10.00 a.m. positively. For details in this regard log on www.skuastjammu.ac.in
3. The candidates invited for attending the counselling are more than the number of seats available. However this is to accommodate the shortfall or vacancy arising, if any.
4. **The provisionally selected candidates shall have to deposit requisite fee in full on the day of counselling.** Accordingly, they shall candidates are advised to come prepared for the same. For the detailed fee structure, visit information brochure CET-2026 available on the University website: www.skuastjammu.ac.in.
5. **Mode of Payment: Online mode (UPI / Net Banking)/ offline mode at the counter of J&K Bank at the Venue of the Counselling.**
6. The provisionally selected candidate who fails to deposit the fee on the prescribed date of counselling, his/ her provisional selection shall be treated as cancelled and the seat in that case be declared as vacant which subsequently shall be filled in the next round of counselling, as the case may be.
7. The candidates are directed to fill in the **OPTIONS FORM FOR UG/PG COUNSELLING** which shall be downloaded from the University website www.skuastjammu.ac.in
8. The candidates provisionally selected/admitted under Self-Financing and NRI /OCI category shall have to make an undertaking to the extent that he /she is in a position to pay the Self-Finance/NRI/OCI Category fee for the whole duration of the degree programme and shall not request for any concession/exemption of fee at any of time point during the course of degree programme.
9. Up-gradation will be permitted only in 2nd, 3rd and 4th rounds of counselling in case of admission to Undergraduate Degree Programme and 2nd and 3rd round of counselling in case of Postgraduate Programme. No upgradation shall be permitted in the mop-up round of counselling.
10. Seats falling vacant on account of upgradation during a particular round of counselling shall not be filled in the same round of counselling.
11. **Refund of Fee: A candidate who wishes to cancel his/ her admission must formally submit an application for cancellation of admission in the office of the Registrar before the commencement of the fourth round of counselling.**

The candidate is required to attend the counselling on stipulated date/time, venue and present himself /herself before the counselling committee when his/her name is announced, failing which the claim of admission on seats available at that point of time when he/she was called shall not be entertained in spite of superior merit. The allotment of seats for candidates who present themselves before counselling committee afterwards shall depend upon availability of seat(s) at the point of time, when he/she presents himself/herself before the Counselling Committee of SKUAST-J in the counselling hall only on stipulated dates of counselling.
13. For Self-Finance Category, in each degree programme, the selection of desirous candidates shall also be strictly based on merit obtained in the SKUAST-J, CET-2026.
14. The candidates are advised to visit University website www.skuastjammu.ac.in for other details and updated information.
15. Please note that candidates from outside the J&K and Ladakh that their prepaid mobile services may not work.
16. All other terms and conditions as mentioned in brochure shall remain as such.
