PART-I

General Undertaking

1. We have carefully read and understood the Hostel Rules, University Regulations, Leave Rules, Mess Rules and all instructions issued by the University from time to time.
2. We undertake that the student shall abide by all rules, regulations, notifications and lawful directions issued by the University and Hostel Administration.
3. We undertake that the student shall maintain discipline, dignity, good conduct and decorum within the hostel and University campus.

PART-II

Hostel Conduct

4. The student shall reside only in the room allotted by the University and shall not change rooms without prior permission.
5. The student shall comply with hostel timings, attendance requirements and leave procedures.
6. The student shall obtain prior permission before leaving the hostel for overnight stay or absence wherever prescribed.
7. The student shall not permit any unauthorized person to stay in the hostel room.
8. The student shall maintain cleanliness and hygiene in the room and common areas.
9. The student shall maintain an atmosphere conducive to study and shall not create disturbance through loud music, parties or disorderly conduct.

PART-III

Prohibited Activities

10. The student shall not indulge in bullying, harassment, intimidation, violence or abusive behaviour.
11. The student shall not possess, consume or distribute alcohol, narcotic drugs, tobacco products, e-cigarettes or any prohibited substance.
12. The student shall not engage in gambling, betting, money lending, unauthorized commercial activities or any unlawful act.
13. The student shall not possess weapons, explosives or hazardous material.
14. The student shall not keep pets or use unauthorized electrical appliances prohibited by the Hostel Administration.
15. The student shall use information technology resources and social media responsibly and shall not indulge in cyberbullying, online harassment, unauthorized publication of University-related material or any act bringing disrepute to the University.

PART-IV

General Declaration

16. The University authorities shall have the right to inspect hostel rooms whenever required.
17. The University reserves the right to amend hostel rules from time to time.
18. The decision of the competent authority relating to hostel administration and discipline shall be final and binding.
19. Violation of Hostel Rules or this undertaking shall render the student liable to disciplinary action under the applicable University Rules.
