Sub: Provisional Admission to B.Sc. (Hons.) Agriculture/ B. Tech. Biotechnology/B.Sc. (Hons.) Horticulture /B. Tech. Agril. Engineering / B.Tech. Dairy Technology and B.Sc. (Hons.) Life Sciences Degree Programme after 3rd round of counselling for the academic session 2026-27.

Consequent upon the recommendations of the Admission cum Counselling Committee the selected **candidates as per the list (Stream-Wise) enclosed as Annexure-I**, to this notification are granted provisional admission in the academic session 2026-27, subject to the condition that if at any point of time during the course of study programme, information furnished by a selectee is found incorrect or misrepresented/concealed or suppressed in any form, the admission granted would be cancelled forthwith without assigning any reason and this University shall be at liberty to initiate the necessary action under rules against such selectee.

The selectee who has attended the counselling, but has not paid the prescribed fee as indicated against his/her name in the selection list, shall be treated as cancelled and the seat in that case be declared as vacant which subsequently shall be filled in the next round of counselling, as the case may be.

The provisionally admitted/selected candidates are advised to report to the University at Baba Jitto, Auditorium SKUAST-Jammu, Chatha on **13th and 14th of August, 2026 at 10:00 a.m. to 04:00 p.m** along with their original certificates, two sets of self attested photocopies of testimonials, 03 Passport size photographs (in blue/red background) and duly filled in Admission Form along with other documents (which shall be downloaded from the University website: www.skuastjammu.ac.in).

The candidates shall have to report to the concerned Dean of the Faculty on **17th & 18th of August, 2026** (along with a complete set of all the documents & 03 Nos. of Passport size photographs) for registration in the 1st year /1st semester of the academic session 2026-27.

The candidates who fail to report for admission in the University on the aforesaid dates his/her admission shall be treated as cancelled.

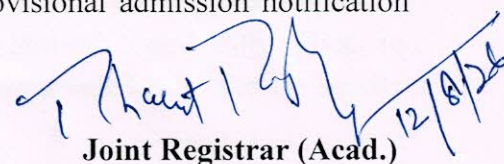
